

### SURVEY: Religiosity, spirituality, and volunteering motivations and behaviour



My name is Katja Petrovic and I am conducting a survey study towards a PhD at La Trobe University. The aim of my study is to gain a better understanding of what motivates people to volunteer, or prevents people from volunteering, with a specific focus on religiosity and spirituality.

	As I've said many times before, the word "Islamophobia" has been grossly misused to mean "hatred or fear of Muslims". But look—the word is "ISLAMophobia", not "MUSLIMophobia"! And there are many who do have that latter form of bigotry, including the front-runner for the Republican Presidential nomination, Donald Trump. Trump is a "Muslimophobe." The term "Islamophobia" is all too often used to characterize those not who dislike <i>Muslims</i> , but who dislike the <i>ideology</i> that drives many of them to perform either terrorist acts or oppressive behaviors, like the subjugation of women and the demonization of gays. While demonization of Muslims as a group is unjustified bigotry, criticism of Islam—whether you agree with it or not—is justifiable free speech, and a dialogue worth having.

## REPORT: In the battle for marriage equality, we must not forget to fight against religious exceptions - Alastair Lawrie

The long struggle for marriage equality does not involve waging just one battle. Instead, it includes a range of related, and sometimes overlapping, fights for lesbian, gay, bisexual, transgender and intersex (LGBTI) equality.

Obviously, there is what most would consider to be the 'central' fight – to amend the *Marriage Act 1961* to ensure all LGBTI couples who wish to can be married under secular Australian law. Victory on that particular issue is long overdue.

A closely-related fight is ensuring that the definition used to amend the *Marriage Act* is sex and gender neutral – referring to the union of two persons (replacing man and woman which is currently used in section 5) rather than referring to man/man, or woman/woman, unions. The latter would only be gay or same-sex marriage, instead of genuine marriage equality, and would continue to deny equal rights to some members of the LGBTI community.

this is something
that we will need to
be vigilant about
until equality is
finally achieved in
Australia (whenever
that might eventually
be).

Another related fight is removing the abhorrent 'forced trans divorce' provisions in respective state and territory laws. As I understand it, these provisions will not automatically be overridden by the passage of marriage equality legislation federally, meaning we will need to continue fighting until the last of these offensive laws is repealed.

And then there is the current procedural fight about *how* marriage equality should be implemented – with Malcolm Turnbull's Liberal-National Government intent on holding an unnecessary, inappropriate, wasteful and divisive plebiscite.

### **REPORT:** Royal Commission hosts criminal justice public roundtables

The Royal Commission into Institutional Responses to Child Sexual Abuse is holding a series of public roundtables in April to discuss a range of criminal justice issues with invited participants.

The public roundtables follow March's public hearing into criminal justice issues.

Royal Commission Chief Executive Officer Philip Reed said the public roundtables will discuss adult sex offender treatment programs, Director of Public Prosecution's (DPP) oversight and complaint mechanisms and reporting offences.

"These roundtables will invite comment and discussion from a range of participants, including police, public prosecutors, criminal justice policy officials, academic and practitioner experts and others," Mr Reed said.

"Consultation through these public roundtables will help inform the Royal Commission's criminal justice policy work," Mr Reed said.
