REPORT: A short note on apostasy and atheism globally and with special focus on the Middle East and Iran

The majority of the countries that criminalise apostasy are located in the Middle East and North Africa, and/or have Muslim majority population, however according to the Pew Research Center's report (2014), in addition to the abovementioned "nearly a quarter of the world's countries and territories (22%) had anti-blasphemy laws or policies, and one-in-ten (11%) had laws or policies penalizing apostasy" of which Ireland, Denmark, Italy and Germany are outstanding. Finland also criminalises "Breach of sanctuarity of religion" with a penalty of fine or 6 months in prison (Chapter 17, Section 10). The legal punishments for such transgressions vary from fines to death.

REPORT: Religious Charity! What's it good for?

Scott Morrison will hand down the budget on 3rd May with one glaring omission – the nation's irreligious.

A national poll in March showed 64 per cent of Australians oppose religion being tax-exempt. Yet hundreds of diverse church denominations avoid an estimated \$31 billion in tax each year, simply because of the historical anomaly of 'advancing religion'.

The Australian Charities and Not-for-Profit Commission (ACNC) administers over 60,000 charities with almost 60% being secular organisations. Whereas a number of religions run hundreds of private enterprises in schools, hospitals, aged care, and a variety of other private businesses – none of which pay income tax, GST, rates, car registration and a raft of other taxes.

REPORT: Iceland officially worshipping Norse gods again

Icelanders will soon be able to publicly worship at a shrine to Thor, Odin and Frigg with construction starting this month on the island's first major temple to the Norse gods since the Viking age. Worship of the gods in Scandinavia gave way to Christianity around 1,000 years ago but a modern version of Norse paganism has been gaining popularity in Iceland.

"I don't believe anyone believes in a one-eyed man who is riding about on a horse with eight feet," said Hilmar Örn Hilmarsson, high priest of

Ásatrúarfélagið, an association that promotes faith in the Norse gods. "We see the stories as poetic metaphors and a manifestation of the forces of nature and human psychology."

Dear Members,

Following is a letter template initiated by a member in light of the upcoming federal election in order to express concern regarding refugees. If you find this letter matches your views, please feel free to use this wording and send to your local candidates:

We the undersigned reject the current approach to Australia's refugee policies adopted by both major parties and some xenophobic populist minor parties. We do however recognise that within parties there is a diversity of views and would be prepared to support and advocate for individual candidates who would work for a more compassionate approach based on Australia's international obligations and our shared history of accepting and helping refugees. It is in that context that we seek your views and commitment to work, if elected, to:

- 1. Have all existing and new applicants for refugee status processed onshore and according to Australia's international obligations;
- 2. Ensure that process is quick, fair and transparent and that successful applicants are released into the Australian community with full rights:
- 3. Work with regional governments and the international community to reduce the risks of flight from persecution and to ensure that people's right to seek refuge is facilitated.

REPORT: The Australian Catholic Bishops Conference has decided that it needs to "weigh into" the 2016 Federal Election.

It has done so under the guise of "speaking up for the voiceless" and "thrown-away people", and their statement specifically lists many marginalised peoples who are most worthy of support – which ironically includes survivors of sexual abuse.

A few salient facts on this point have been missed, such as that:

- a distressingly high number of abuse survivors emanate from abuse by religious personnel;
- religious institutions in particular, and the Catholic Church specifically, have actively contributed to the "throwing away" and "silencing" of those survivors through not believing and supporting them, not encouraging them to go to police, moving and protecting abusive priests, offering only derisory compensation and attaching confidentiality clauses to even those token amounts.

The Atheist Foundation of Australia (AFA) suggests that the Catholic Church should prioritise getting its own house in order on these issues, prior to purporting to speak on the behalf of victims of abuse. As the <u>Royal Commission into Institutional Responses to Child Sexual Abuse</u> demonstrates, there is still a long way to go.
