Victorian Government Multicultural Policy Consultation

Submission Summary:

- 1. Replace the term 'Islamophobia' with 'anti Muslim bigotry'
- 2. Inter-belief
- 3. Omniculturalism

We are grateful to the Minister and Department for giving us this opportunity to submit feedback on this policy document. The aims and objectives of our organisation are listed as an Appendix.¹

Overall the Victorian Government Multicultural Policy document² clearly expresses concern for human rights and equality for all diversity of citizens within the context of our secular democratic society.

1. Replace the term 'Islamophobia' with 'anti Muslim bigotry'

There is a legitimate concern in the world today that Muslims (and those who might be perceived as Muslim) might be subject to attack simply based on their faith identity (real or perceived). Progressive Atheists denounce such attacks.

Progressive Atheists have particular concern for the use of the term 'Islamophobia' in the document under the heading "Promoting human rights and equality". The irony of this is that Muslims who have been promoting minority positions within their faith tradition have been shut down from expressing their point of view by the use of the term 'Islamophobia'.

We are concerned that minorities holding a Muslim identity, and their supporters, are prevented from speaking freely about their own interpretation of Islam and how that contrasts to other interpretations, or expressing their personal experiences within the Islamic tradition.

Progressive Atheists would like to propose that the term 'Islamophobia' be replaced in the document with the term 'anti Muslim bigotry', in order to better specify the concerns held, without restricting freedom to scrutinise or criticise ideas.

We would also like it to be noted that Progressive Atheists meetings attract a wide variety of attendees, many of whom are recent immigrants to Australia from countries such as Iran, Pakistan and Bangladesh, who would be persecuted for their beliefs in their country of birth due to blasphemy and apostasy laws. Progressive Atheists Inc. is a community organisation that is actively supportive of these emergent groups.

"Critiquing Islam, critiquing any idea, is not bigotry. "Islamophobia" is a troubled and inherently unhelpful term. Yes, hatred of Muslims by neo-Nazi style groups does exist, and it is a form of cultural intolerance, but that must never be conflated with the free-speech right to critique Islam. Islam is, after all, an idea; we cannot expect its merits or demerits to be accepted if we cannot openly debate it... My view is that no idea is above scrutiny, and no people are beneath dignity."

2. Inter-belief

The term 'Inter-faith' is in common use to describe people from different faith traditions coming together. Progressive Atheists would like to encourage the use of the term 'Inter-belief' in order to be inclusive of non-religious individuals and groups and individuals as part of societal narratives.

3. Omniculturalism

Maajid Nawaz has also made comment on the policy of Multiculturalism⁵, which has lead to failings of integration in the UK. Maajid recommends consideration of Omniculturalism⁶ where education about group-based differences is only taught after children have learned about our human commonalities.

Progressive Atheists supports an investigation into the merits of Omniculturalism, especially with regard to focusing primarily on our commonalities, and seeing that all humans have a shared humanity. This policy may provide greater freedom for individuals to have mobility in their identity, rather than feeling subjected to a group identity.
